- d. discussed NDOT mounding, is there a need for signage
  - NDOT encourages aesthetic improvements that don't detract from roundabout safety (concern of "too many" signs that may distract drivers)
- e. discussed TRPA permitting process, Design-Review guidelines
  - i. TRPA supports "gateway features" referenced Environment Improvement Program

  - John L'Etoile discussed District II permit process, and input to date;
     Kelly, Alma from engineering

- ii. John highlighted necessary awareness to plant choices in roundabout

   constant sand and brine in surrounding roadways can easily
   damage the landscape investment
- iii. John highlighted that a maintenance agreement is absolutely necessary to ensure upkeep to Incline Village community standards ("maintenance like your own home garden")

# d. Washoe County

 Dave Solaro / County want to be a good steward here, all the while balance various needs in the community. Project will need Planning review for Area Plan conformance

## e. TRPA

- i. defers to NDOT on safety, appropriate design as landowner
- ii. Will accept permit from operating entity, signed by NDOT as landowner

#### f. IVGID

- i. Hudson/Bob Harrison A meter account could be set up for IVCBA as third party
- ii. Curious about "off-site" features added to design for traffic calming (ex: rumble strips, blinking light)

# 6. Agency Updates – 3:50pm

- a. NDOT: Update on internal discussions, roundabout and adjacent stateowned yard, and general support.
  - i. Kelly: NDOT lead project Engineering selection may need to conform to procurement process in conformance with law; Permittee would be whomever "owns" the enhanced landscaping (i.e. IVCBA) as NDOT would not do that level of maintenance
- b. Washoe County: Community support, adjacent land ownership, and potential opportunities.
- TRPA: Overview of jurisdictional responsibilities (grading, signage, traffic, scenic) and permitting.; Could be EIP project, see Design-Review guidelines
- d. IVGID: Water service discussion and potential community support.

## 7. **Primary Issues Discussion** – 4:00pm

- a. Safety (NDOT) Design meets all current standards for safety. Consider mounding but more to protect landscape. NDOT to vet safety further with their engineers. There are lots of accidents, so needs to be considered.
- b. Beautification (IVCBA) mutual discussions between IVCBA and NDOT that aesthetics could be improved. NDOT does not typically provide maintenance to support such a project and agreements would need to be established for long term maintenance.





- c. Irrigation Water / Power needed (NDOT, Washoe Co, IVGID)
- d. Next steps Design criteria (NDOT, TRPA, IVCBA)
  - NDOT submittal requirements (30% Design); John L'etoile will continue working informally with us for now to prepare for 30% package
  - ii. TRPA submittal requirements / EIP? Discussed earlier with Shannon/Ryan
  - iii. MOU/Inter-local agreements; Discussed earlier with NDOT/IVCBA
- e. Funding (IVCBA, NDOT, Washoe County, IVGID); Linda: Public Private partnership envisioned; They are confident in fundraising. Long-term maintenance costs to also be considered
  - i. IVGID is in support of additional funding added to budget for longterm maintenance plan/resources
